

UNITED RELIGIONS INITIATIVE: REPORT OF VISIT BY INTERNATIONAL DELEGATES TO THE UNITED KINGDOM March 2024

A delegation of representatives of the worldwide interfaith organisation, the United Religions Initiative, visited the English Midlands and London on 1 - 4 March 2024 at the invitation of the United Religion Initiative UK (uriuk.org).

The visit was primarily designed to introduce the delegation to the UK model of inter faith dialogue and faith-based social action, and to provide UK-based inter faith activists with helpful insights from abroad. One such insight was the Public Health Approach to Violence, a new approach towards isolating and disrupting patterns of violent behaviour, which has become well-respected in the USA since 2000. The conferences held during the visit served as an ideal forum to facilitate conversations about the Public Health Approach, particularly regarding religion-motivated violence (see Section 4).

The conference participants strongly encouraged URI UK to plant and cultivate the Public Health Approach in UK urban contexts, initially through pilot schemes in selected urban locations. This work will form the subject of applications to appropriate funders, who are invited to read the following report as part of their consideration.

1. Introduction – what is the United Religions Initiative?

The United Religions Initiative (uri.org) is a United Nations affiliate organisation founded in California in 1998 by retired Episcopalian Bishop William Swing as part of the 50th anniversary commemorations of the signing of the UN Charter. His purpose was to bring different faith groups together in fellowship and productive endeavour, thus mirroring the purposes of the UN in the religious sphere.

URI has become the world's largest interfaith network, with over 1,150 member grassroots groups ('Cooperation Circles') in 110 countries, divided into eight global regions.

These are actively engaged in areas including youth and women's empowerment, environmental protection, promoting freedom of religion and belief, and fostering multifaith cooperation to address social issues.

URI Europe is one of the URI's most active global regions, with more than 60 Cooperation Circles across 25 countries. Its secretariat is in Bonn, Germany.

United Religions Initiative UK (URI UK) is a registered charity and part of the URI Europe network. It pursues URI's global aims within the UK context: building bridges of cooperation among diverse religious and spiritual communities, fostering understanding and collaboration, helping to end religiously motivated violence, and creating cultures of peace, justice, and healing.

It was re-established in 2022 following some years in abeyance and currently links four UK-based Co-operation Circles. Its activities have included a youth conference on Freedom of Religion and Belief and a multi-faith celebration of the King's Coronation

It focuses as much on social action projects – bringing people together by doing positive work in communities – as on interfaith dialogue. It works with all who share its values, such as places of worship, youth groups and community activists, and it welcomes people from any background and of all faiths or none. It is based in the West Midlands.

2. The visit programme

Between 1st and 4th March 2024, members of the URI Europe board and secretariat (from Belgium, Bosnia-Hercegovina, Bulgaria, Germany, the Netherlands, and Spain) visited the UK as guests of URI UK. A full list of delegates is at Annex B. Based at Coleshill in the West Midlands, they travelled to five religiously diverse innercity districts over four days: Handsworth in Birmingham, Oldbury in the Black Country, the Golden Mile in Leicester, Swanswell Park in Coventry, and the London Borough of Barnet. They were accompanied by the Chair, Executive Director and Director of Global Programmes of URI Global, all based in the USA.

The ten delegates' visit to the UK came during significant global and local challenges to good relationships between people with differing religious adherence. The delegation brought fresh perspectives to help galvanise interfaith activity in the Midlands and London and learn about the UK model of interfaith dialogue and multifaith cooperation. URI UK, URI Europe, and private donations met the costs of the visit.

The visit included visits to places of worship (including observing acts of worship), a touring exhibition, shared meals, and conferences in the five host venues. The conferences addressed some complex themes: preventing religion-motivated violence, building cultures of peace and justice, the fragility of interfaith work, and promoting enduring, daily interfaith cooperation to address social issues.

They were designed to discover innovative ways for faith groups and other stakeholders to work effectively, inspire people to action, bring hope, and create opportunities and prosperity for local communities. They featured contributions from prominent interfaith activists, clergy of different faiths, a Member of Parliament, a Police and Crime Commissioner, academics, and local Councillors, followed by table discussions and a shared meal.

Audiences included those new to interfaith dialogue and more seasoned practitioners, and URI UK is grateful to its local partner bodies for attracting such a wide range of participants. URI UK hopes that UK interfaith initiatives will choose to become URI Cooperation Circles due to the visit, giving them access to resources and contacts worldwide. At the time of writing, two multi-faith groups had chosen to do so.

Specific objectives of the visit programme:

- a) To introduce the international delegation to interfaith practice and issues in the UK and to provide forums for sharing their perspectives with UK practitioners.
- b) To explore the threats that presently face interfaith understanding, thereby advancing URI's purpose and action agenda; in doing so, to reach out to relevant partners and potential new Cooperation Circles.
- c) To promote the Public Health Approach to Violence Prevention (see section 4 below) and explore the possibility of a partnership to work on this issue in the UK.
- d) To offer the Board of URI Europe and URI Global senior management an opportunity to meet and plan future activities.
- e) To provide the delegation with quiet reflection and spiritual uplift opportunities.

A press release was issued at the start of the programme. This is reproduced in Annex A.





3. Summary of conferences

This section provides a summary of the five conferences. An opportunity for questions and table discussions followed each. Following the Cooperation Circle model, URI UK endeavoured to place at least seven delegates from at least three different faith backgrounds on each table.



There were pre-set topics for discussion, designed to encourage the tables to produce practical proposals for multi-faith cooperation that could be realised quickly and without significant resource outlay.

Points made in the table discussions are summarised in Annex C. (At the London event, the decision was taken to hold a group discussion following the presentations rather than table discussions.)



4. The Public Health Approach to Violence Prevention

Addressing all five events, Jerry White, URI Global's Executive Director and a former joint winner of the Nobel Peace Prize for his campaigning work on landmines, introduced audiences to the concept of the Public Health Approach to Violence Prevention. He explained that violence should be seen not as an innate condition of specific individuals but as a pathological behaviour akin to a physical disease. Just as a contagion of disease is effectively tackled by outbreaks being contained and interrupted, so there are powerful techniques for containing, deflecting, and interrupting violence and stopping it from spreading – whether this be a violent crime, domestic violence, racist violence, or religion-motivated violence.

This approach, which has obtained widespread academic endorsement, has also gained favour among crime prevention policymakers in the United States in the last two decades. URI UK believes that it has clear applicability in the context of religion-motivated violence in UK contexts, whether this takes the form of Antisemitic incidents during pro-Palestinian protests in significant centres and on campuses or the Hindu-Muslim riots that were experienced in the previously well-integrated city of Leicester in 2021.

Therefore, URI UK took the opportunity of the five conferences to test audiences' reactions to the 'Health Approach'. This occurred in the table discussions and informal conversations over refreshments after the events. Reactions to the Approach were strongly positive, with many delegates feeling it should be tried in Britain. Some actively encouraged URI UK to help develop it further.

URI UK feels that this consultation method, whilst admittedly not rigorous in academic terms, provided a sufficient indication of support among interfaith activists to encourage us to develop proposals for a pilot scheme to test the impacts of the Public Health Approach to Violence Prevention in selected urban locations, likely to be in the Black Country. These will include online training in Health Approach techniques by an expert in the US and outreach/awareness-raising activities.

5. Conclusion

URI UK believes that the visit programme, whilst perhaps intensive, amply met its objectives:

- UK interfaith activists and religious leaders gained fresh perspectives from our international visitors and had opportunities to forge new partnerships and generate new project ideas;
- Our visitors learned much about the UK interfaith scheme, nationally and locally, and gained an
 understanding of the challenges it has faced in recent years (and continues to face, with the
 regrettable closure of the Inter Faith Network for the UK);
- The Public Health Approach to Violence Prevention was explained to UK audiences for perhaps the first time, and there was much enthusiasm to see it rolled out in the UK context as appropriate.

Feedback from the international delegation was strongly positive, with comments including:

OBAMA ADVISER AND NOBEL PEACE PRIZE WINNER TO VISIT UK.

Preeta Bansal, President Obama's former senior policy advisor, will visit the West Midlands, Leicester, and London between March 1 and 4.

Ms Bansal, an American social entrepreneur, is the Global Chair of the United Religions Initiative (URI), the world's largest interfaith organization. She will be accompanied by the executive director of URI, Jerry White, a campaigner, and humanitarian activist who shared in the 1997 Nobel Peace Prize for his work in banning landmines.

The two will be part of a delegation of URI activists from the United States and Europe coming to Britain at the invitation of URI UK, a charity headed by Deepak Naik MBE from Coventry.

The visit will include visits to places of worship, a touring exhibition and conferences in Birmingham, Sandwell, Leicester, Coventry, and London. These will address difficult themes such as preventing violence in all its forms and the fragility of interfaith work.

The conferences are designed to discover innovative ways for faith groups and other stakeholders to work effectively, inspiring people to action, bringing hope, and creating opportunities and prosperity for local communities.

Deepak Naik said, "Events in the Middle East and elsewhere are posing real challenges for good relations between faith groups here in Britain. On top of that, we learned of the tragic closure of the Inter Faith Network for the UK, which has done outstanding work in supporting dialogue for over 25 years. It is vital to strengthen interfaith activity in the UK and draw in new participants."

Preeta Bansal said, "Britain has always had a good reputation for interfaith dialogue, and my colleagues and I are keen to learn more. We also hope our experiences will provide fresh perspectives for activists here and give rise to new projects and approaches."

The conferences will feature keynote speeches from prominent interfaith activists, MPs, local councillors and panel discussions designed to produce practical projects and working partnerships.

URI UK hopes that UK interfaith initiatives will choose to become URI 'Cooperation Circles' because of the visit, giving them access to resources and contacts worldwide. SUMMARY OF TABLE DISCUSSIONS

BIRMINGHAM

Barriers to cooperation between faith groups

- Lack of understanding, prejudice between people of faith and general public
- Self-isolation of faith groups, lack of courage
- Government tone from the top
- Media negative, sensational
- Poverty
- Lack of faith education leading to fear
- Poor understanding of religiously-motivated violence

General themes

- Listening is powerful be respectful and open to others different to ourselves, making space for the other, celebrating difference, developing love to challenge fear
- Create safe, welcoming spaces for dialogue, including challenge
- Mindset shift through education instil a common language of virtues/values, learning from faith as well as about faith; needs to start early to build spirituality, identity, security
- Restorative justice: listening to people who are hurting, recognising the impact of actions
- Keep things simple a cup of tea, connection, understanding the power of networking
- Connecting with other generations: experience and innovation
- Health model find solutions to underlying causes of religiously-motivated violence, e.g. ignorance, politics, cultural change
- Embrace the 'solution focused' model of religion

Practical ideas

- Address ignorance by visiting each other's places of worship
- Make sure we are working with existing networks and resources
- Better, quicker use of social media channels to tackle hate speech
- Identify common causes and joint projects, building trust to implement effective action in the community
- Hold those with influence accountable (MPs, Councillors)
- Defend other faiths when attacked: stand united and supportive of other religions

SANDWELL

Barriers to cooperation between faith groups

- Poor communication, ignorance, not knowing each other lack of relationship and trust
- Judgmentalism, "I'm all right Jack"
- People grow up with myths divorced from reality
- Not enough people want to engage, or are too busy
- Central government ideology
- Youth identity is fixed early, leading to labelling of 'the other'

General themes

- Need to find common needs/causes, e.g. addressing antisocial behaviour, racism, crime, community safety, cost of living, mental health, homelessness
- Strengthen the idea of Equity
- Better religious education, including about interfaith
- Find role models
- Be curious and keep an open mind, more listening leads to more acceptance and understanding of each other's beliefs, culture and needs
- Debate should aways be respectful, recognising that there is more than one story
- We have more in common than divides us

<u>Practical ideas</u>

- Set up a Friends group or a Neighbourhood Watch
- Better use of Facebook and other social media to promote community cohesion
- Create safe spaces for open discussion of community issues
- Better promotion/advertising of religious festivals and community days
- Reach out to decision makers a collective voice is stronger
- Reach out to smaller faith groups
- Raise general/business awareness of what faith groups contribute to the local area
- Make better use of existing groups e.g. West Midlands Faith Alliance
- Set up action groups or workshops to address specific issues in local areas
- "More of this" create opportunities for informal conversations
- Shared pilgrimages
- Training for faith leaders in how to reach out to new migrant communities, e.g. through social media

LEICESTER

Barriers to cooperation between faith groups

- There is often an unhelpful element of competition between faith groups
- Conflict between faith groups abroad stirs up anger and resentment in Britain
- Among young people there is sometimes a gang mentality, seeking affirmation within their own group
- Misguided 'political correctness' in local authorities, leading to the banning of e.g. Christian nativity plays
- Parents can prohibit their children from visiting people/places of worship of different faiths
- Underlying factors such as deprivation and poverty can be articulated in religious ways
- People in positions of power using "divide and rule"
- Important public information does not reach ordinary community members

General themes

- If we turn back to the genuine teachings of our faiths we will become more united
- People generally want to 'get on', including people without religious beliefs
- Just sitting with people of your own faith does not bring progress
- Parents should educate their children about the benefits of engagement between faith groups; it
 is important for children to meet/visit people of other faiths

- Schools should offer teaching on the value of interfaith: universal values, love, unity and respect
- Think for yourself, establish the facts, exercise diligence
- Cooperation between faith groups is critical and preventing/stopping civil unrest
- We should listen to the opinions of 12/13 year olds, and make early interventions to address prejudiced attitudes
- Community members should take ownership of their contribution to community tensions, and stop adding fuel to the fire
- There should be a concentrated effort to address misconceptions about faith among media and policy makers
- Interfaith groups should make sure that the voices of people from different backgrounds is heard, not just male religious leaders from the traditional faiths
- Recruitment to public roles/offices should be as diverse as possible, to provide strong role models
- 'Relatable' people should be the public face of different faiths
- Community relations efforts should find a way of integrating the LGBTQI+ community and refugees
- Need to have safe, non-judgmental spaces for difficult conversations

Practical ideas

- We should offer hospitality/meals to people of different faiths in our homes
- Small groups of different faiths could get together to compare scriptural verses, thus realising commonalties and broadening minds
- When a tense situation arises, community workers should lead face-to-face sessions between faith leaders in neutral venues, to address matters of concern
- Using personal connections, existing interfaith groups should incentivise new members to take part, focusing on high-risk groups through formal invitations, VIP speakers, refreshments etc
- Young volunteers in places of worship should be asked to do rapid-response to hate speech on social media
- Places of worship could hold open weekends (Mosaic weekends) to raise awareness

COVENTRY and LONDON

General themes

- Religious education should involve children, young people and adults (intergenerational) and should have a focus on peace
- Women are prominent in the field of combatting hate crime and religiously-motivated violence, their experience and expertise should be more widely shared
- Interfaith has been too cautious; in the present environment there should be "a muscular call to arms"

Practical ideas

- A 'Peace Picnic' to bring children of different faiths together
- Interfaith Youth Camps for teenagers
- Interfaith dialogue to be a part of visits by young people to twinned cities, could start online
- 'Rapid response' to hate speech on social media
- URI UK could host 'difficult conversations' workshops
- URI could run a competition for public/digital art on community relations themes
